"The good news is that thanks to the work we have been doing over the past 20 years, we have observed through outcome data that youth have demonstrated a desire to postpone sexual activity." We often hear about health risks associated with sexually risky behaviors, such as the risk of acquiring sexually transmitted infections (STIs). Although sexually active individuals can reduce the risk of STIs with preventive measures, such as condoms, young people do not consistently use them nor do they always use them correctly. Avoiding sex altogether is the only sure way to avoid its associated risks, such as STIs, pregnancy or other regrets. This is why providing risk avoidance education to young people about non-marital sex is important.

This information can include learning about emotional and health issues, including misperceptions. For example, many sexually active youth are surprised to learn that the majority of teenagers in this country are not having sex; however, in some of the high-risk communities where we work many teens are sexually active. This demonstrates a disparity between at-risk communities versus those in the rest of the country.

The good news is that thanks to the work we have been doing over the past 20 years, we have observed through outcome data that youth have demonstrated a desire to postpone sexual activity. We have accomplished this by providing youth with correct information and support systems. This holds true across communities, whether in West Virginia or in urban St. Louis.

We will expand this work with three of our partners: Mission West Virginia, serving seven counties in West Virginia; Trinity Church, Harlem, New York; and Opportunities Industrialization Centers of South Florida (OIC-SFL), Broward County, Florida.

I am excited to work with each of these partners because ...

MISSION WEST VIRGINIA (MWV) has the ability to cost-effectively take programs to scale. When MWV partners with a particular county and school district, the staff are all-in and their well-established support system truly makes a difference. The relationship that AMTC has with MWV as the lead organization consistently results in performance outcomes that are attained. As an evaluator, that always excites me!

TRINITY CHURCH in Florida is a partner we have worked with since 2006, and we look forward to building a relationship with Trinity Church in Harlem. They have an amazing staff that is personally committed to the work. In every classroom setting, it is clear that students connect with educators and their support system. Their amazing leadership team enables programs to be implemented with fidelity.

OIC is one of AMTC & Associates' earliest clients. They recognize that the onset of issues that families face is critical to a future success sequence, exactly what SRAE legislation addresses. OIC has a youth and a workforce development department. I am excited to observe how their staff will introduce the success sequences in conjunction with their education and training.

AMTC will assist the above-referenced partners by coordinating effective training programs and measuring performance through pre-and post-surveys. We will also provide technical assistance and a re-tooling program model if outcomes are not realized in accordance with the logic model. Through these measures, we will do all we can to help ensure that our partners are successful so that young people are making better decisions about their sexual choices and future life goals.

Providing Sexual Risk Avoidance Education (SRAE)

Teenagers who engage in risky behaviors, sexual or otherwise, often do not see the long-term consequences of those actions. It not only affects youth but our entire community. For those reasons and more, the Department of Health & Human Services' Administration for Children Youth and Families (ACYF) sponsors grants for organizations to deliver Sexual Risk Avoidance Education (SRAE). According to ACYF, "The purpose of the SRAE program is to fund projects to implement sexual risk avoidance education that teaches participants how to voluntarily refrain from non-marital sexual activity."¹ Programs must be evidence-based and serve populations that need services the most.

Torri Childs, Field Research Associate for AMTC, notes that these populations include but are not limited to individuals from the juvenile justice system, residential treatment facilities, runaway and homeless shelters, and those in and aging-out of foster care. Youth in poverty and sexual minorities (LGBTQ) are also served.

Individuals who are served by these programs often face multiple issues. ACYF recognizes that these factors are complex; therefore, it allows grantees to use funds to provide case management and referrals to support services in community-based organizations.

AMTC is pleased to partner with three organizations that were awarded an SRAE grant:

• **Mission West Virginia** will provide SRAE programs in seven southern West Virginia counties throughout the state. It will serve the above-referenced youth and includes two sub-awardees, Rainelle Medical Center and CASE West Virginia (Community Action of Southeast West Virginia). Over a three-year period, 1350 youth will be served.

• **Trinity Church** will provide SRAE programs in Harlem, New York. Trinity will serve the abovereferenced youth, also with a focus on African-Americans and Latinos. Over a three-year period, 1600 youth will be served.

• **Opportunities Industrialization Centers of South Florida** (**OIC-SFL**) will implement the SRAE in Broward County, Florida. It will target ten zip codes with the highest teen birth rates in the county. In addition to serving the above-referenced youth, OIC-SFL will focus its efforts on addressing substance abuse. Over a three-year period, 1375 youth will be served.

Although each organization is unique and addresses the specific needs of its regions, there are commonalities. Each will use the same evidence-based curricula. *Relationship Smarts PLUS* will be used for middle school youth and *Love Notes* will be used for high school youth. According to Childs, the curricula focuses on healthy relationships, goal setting, resisting sexual coercion, recognizing dating violence, as well as preventing youth risk behaviors.

Staff from the three organizations and AMTC Field Research Associate, Torri Childs, are excited to start programming in January:
