Southwest Key MAKES A DIFFERENCE FOR INDIVIDUALS & FAMILIES



AMTC is delighted to welcome **Southwest Key Programs** (SWK) as its newest client and is excited to work with this exceptional organization. It is one of the largest U.S. Latino-led nonprofit organizations, offering evidencebased programs and essential services to transform the lives of youth and their families.

To say that the organization's offerings are extensive is an understatement. Among them are Youth and Family Services, Unaccompanied Children's Programs, Workforce Development, Home Study and Post Release Services After Family Reunification, and Community Engagement. SWK maintains programs throughout several states, touching individuals and families throughout the nation.

Any focus on children is intricately connected to success within the framework of a family. In the realm of Youth and Family Services, for example, youth in the



criminal justice system not only receive structure and services to promote positive behaviors but also receive the benefits that come from family preservation and parenting support provided to their families. Also, SWK understands that families function within the contexts of school, home, and community and intentionally operates within them all. As an illustration, caseworkers partner with school staff to help with transitions back home from correctional facilities and connect families to community resources.

For children who arrive alone in the U.S., staff work to unify children with their families and/or vetted sponsors immediately upon arrival at SWK. Caseworkers reach out to parents, relatives, or prospective sponsors in the U.S., but that is only one aspect. SWK is involved every step of the way, from the moment a child steps onto its grounds to supporting families after reunification (known as "postrelease"). Staff conduct individualized support plans, visit homes, and offer resources, such as educational, medical, and mental health programs. According to the SWK website (southwestkey.org), "In a typical year, our program helps over 2,500 families receive Post Release Services, enrolls 900 children in local schools, and assists

1,000 families with access to medical and mental health care."

AMTC will partner with SWK on the Substance Abuse and Mental Health Services Administration (SAMHSA) Refugee and Migrant Behavioral Health Technical Assistance Center Grant (see next article). AMTC Research Associate Salvador Dominguez, Ph.D., had this to say: "When we learned about SWK, we became impassioned. We felt a personal stake and motivation in this project given our personal experiences and the research we conducted in the area of refugee and migrant behavioral health."

Southwest Key Programs, Inc., is one of the largest Latino-led nonprofit organizations in the United States. Founded in 1987, SWK has been on the frontline of social justice, youth advocacy, immigration, and helping to nurture the hearts and minds of children, youth, and families.

ELEVATING PROVIDER CAPACITY IN REFUGEE & MIGRANT BEHAVIORAL HEALTH


Well-being is multifaceted, involving not only physical health but also mental and emotional health. For refugees and migrants who have faced challenges such as gender-based and community violence, human trafficking, exposure to child abuse, natural disasters, forced displacement, and legal issues, behavioral health conditions are common, and access to resources is difficult to navigate.

Meeting behavioral health needs is further complicated by the fact that providers who serve refugees and migrants may lack the training, experience, or resources required to fully understand and treat this population. Partnerships and collaborative work among providers and partners can make all the difference in elevating provider knowledge and expertise. This is where SWK is taking the lead. To grow provider capacity in meeting refugee and migrant behavioral health needs, SWK is implementing a Refugee and Migrant Behavioral Health Technical Assistance Center (RMTAC), which is funded by a grant from SAMHSA.

The RMTAC will serve behavioral health providers nationwide through online learning modules, clinical consultation, learning communities, training, web-based resources, and technical assistance. A wide variety of topics will be addressed, such as trauma-informed care, resiliency, and cultural and language competence, to name only a few.

AMTC is honored and excited to serve SWK as its evaluation partner. In this role, AMTC will analyze data to measure the implementation and evaluate the quality of services available to providers who use the RMTAC. Together, AMTC and SWK will deliver in their respective areas of expertise to foster excellence in refugee and migrant care.

EDUCATION: Ph.D. in Public Health - Disease Prevention; Postdoctoral Fellowship in Implementation Science; Bachelor of Science in Health Science

What is your role in supporting the RMTAC?

AMTC provides evaluation, technical assistance, and support on activities, and I am the Co-Principal Investigator for the evaluation of the RMTAC along with Dr. Dominguez. During the proposal stage, I designed the evaluation approach using an implementation science framework and assisted with specifying some of the activities. I am also providing support to SWK by leading the evidence synthesis activity via a literature review and assisting with the online learning communities they plan to offer.

What do you personally find meaningful about this role? Behavioral health is a prominent public health issue nationally. Migrant and refugee populations, especially survivors of human trafficking and forcibly displaced individuals, are particularly at risk. Trying to improve the capacity and knowledge among providers who serve these populations is much needed. We are all passionate about this work and what SWK is trying to accomplish. What do you hope SWK and AMTC will accomplish together?

I hope that the training and technical assistance activities will be useful for providers nationwide, especially in healthcare settings that serve migrant and refugee populations.

What has the experience been like so far partnering with SWK?

It has been great so far. SWK has a large, highly skilled, and diverse team on this project that has been an absolute pleasure to work with.

What is your role in supporting the RMTAC?
